POST AUCTION MEMBERSHIP OPTIONS:

Option 1:

Membership fee of \$500 payable at time of application,
One half of advertised stallion stud fee paid with membership fee, MAAB will allow one mare nomination as per rules of the Auction Futurity,
Horses by nominated stallion and born after 1988 are eligible for the Performance Futurity at current fees and rules, and
Mares bred to the nominated stallion in the year following the auction are eligible to be nominated to the Select and Performance Futurities by December 31, at current fees and rules.

Option 2:

Membership fee of \$500 payable at time of application,
No Auction Futurity nomination is allowed,
Horses by nominated stallion and born after 1988 are eligible for the Performance Futurity at current fees and rules, and
Mares bred to the nominated stallion in the year following the auction are eligible to be nominated to the Select and Performance Futurities by December 31, at current fees and rules.
